## **RFQ: for the Appoint the Service Provider to Store Freedom Park Backup Tapes For 12 Months**

### **1. BACKGROUND**

Freedom Park run daily Backups to ensure business continuity. Freedom Park backups are on disk as well as on tapes. The server software ensures that the schedule is adhered to and to reports any errors that may be experienced. Backup to disk is utilized as a short-term storage method and magnetic tapes are used as a long-term storage method. Tapes should be rotated weekly and should be taken to an offsite secure location. The rotation of tapes is the responsibility of the Freedom Park ICT personnel onsite. Freedom park's ICT personnel is responsible for monitoring the backups and running any corrective action where necessary and responsible for providing the backup rotation schedule. Backup tapes are be changed weekly, a period not exceeding 7 days from the last scheduled backup. Before changing the tapes. Freedom Park ICT personnel removes the used tapes and arrange the move of the tapes to offsite storage and obtain the required tapes for the next backup run as per the rotation schedule. The required tapes must be inspected for any physical damage, also, ensure that the write-protect tab is opened to ensure the tape is write enabled. Backups are monitored through logs every day and failures are actioned accordingly.

## 2. SPECIFICATIONS

- Service provider should be 20km around Freedom Park Pretoria Office for easily access of Tapes in case of disaster strike.
  - Service Provider should have a proven record of Offsite Tape storage service.
  - Tapes must be kept in a clean and dust-free area.
  - Tape storage should not be exposed to heat and humidity.
  - Canisters should be used to store and transport tapes to ensure data is kept safe and not corrupted.

**CERTIFICATE OF INDEPENDENT BID DETERMINATION**

- 1 This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.
  
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
  
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
  - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
  - b. cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.
