### 4 SCOPE OF WORK

#### 4.1 General

This specification covers the design, supply, delivery, installation, testing, commissioning, and maintenance for a period of twelve months of the guarantee period. The installation is an existing installation located at the Admin Block of Freedom park. It is a Heat Recovery Variable Refrigerant system install over fourth floor of a building with 800m<sup>2</sup>.

#### 4.2 Scope

- Test and providing a detailed plant condition report that shall address the state of the different elements of the plant and remedial works required.

The elements of the plant shall be understood to be the electronics, electrical power supplies, outdoor units, indoor units and refrigerant networks.

- Based on the accepted remedial works, a detailed design shall be generated. On approval of the detailed design the remedial works shall be effected at the rates priced in this tender document.
- Note the pricing of item 2 two of the bill of quantities shall be done last to, all other rates shall be priced first so as to inform pricing item 2 of the bill.

- 7.2 This section provides the tenderer with guidelines and requirements with regard to the completion of the Price Schedule. The Schedule has to be completed in black ink and the tenderer is referred to the Tender Specifications in regard to the correction of errors.
- 7.3 The Price Schedule shall be read with all the documents which form part of this Contract.
- 7.4 The following words shall have the meanings hereby assigned to them:  
Unit: The unit of measurement for each item of work in terms of the Specifications and the Project Specifications.

Quantity: The number of units of work for each item.

Rate: The payment per unit of work at which the tenderer tenders to do the work.

Price: The product of the quantity and the rate tendered for an item.

Lump sum: An amount tendered for an item, the extent of which is described in the Price Schedule, the Specification and the Scope of Work, but the quantity of work of which is not measured in any units.

## Rates

- 7.5. If the Supplier is to be paid an amount for the goods which is a fixed price for an item or a fixed price for each of a series of items, the tendering supplier enters the amount in the price column only, the other two columns being left blank.
- 7.6.
