4 SCOPE OF WORK

4.1 General

This specification covers the construction works for the upgrade of the boundary gravel road and the associated stormwater. The construction location is the boundary road of the institution that forms almost a horse shoe around the institution.

4.2 Works specifications

- **Applicable Standard Specifications**

The Standard General and Technical Specifications for Civil Works shall be the COLTO - Standard Specifications for Road and Bridge Works for State Road Authorities (1998).

The Standard Specifications forming part of this contract have been written to cover all phases of work usually encountered on road and bridge contracts and may therefore cover items of work not encountered in this particular contract.

The Contractor is responsible for ensuring that he is thoroughly familiar with all the amendments and corrections before submitting his tender.

- **Applicable National and International Standards**

The Works must comply with certain National and International Standards. These include:

- SANS (SABS)

Where required, compliance with these and other National and International Standards have been specified in the Standard and Project Specifications.

4.3 Scope

The upgrading of boundary gravel road detailed description of the work is provided by the drawings in **section 8**.

7.1 General

7.2 This section provides the tenderer with guidelines and requirements with regard to the completion of the Price Schedule. The Schedule has to be completed in black ink and the tenderer is referred to the Tender Specifications in regard to the correction of errors.

7.3 The Price Schedule shall be read with all the documents which form part of this Contract.

7.4 The following words shall have the meanings hereby assigned to them:

Unit: The unit of measurement for each item of work in terms of the Specifications and the Project Specifications.

Quantity: The number of units of work for each item.

Rate: The payment per unit of work at which the tenderer tenders to do the work.

Price: The product of the quantity and the rate tendered for an item.

Lump sum: An amount tendered for an item, the extent of which is described in the Price Schedule, the Specification and the Scope of Work, but the quantity of work of which is not measured in any units.

Rates

- 7.5. If the Supplier is to be paid an amount for the goods which is a fixed price for an item or a fixed price for each of a series of items, the tendering supplier enters the amount in the price column only, the other two columns being left blank.
- 7.6. 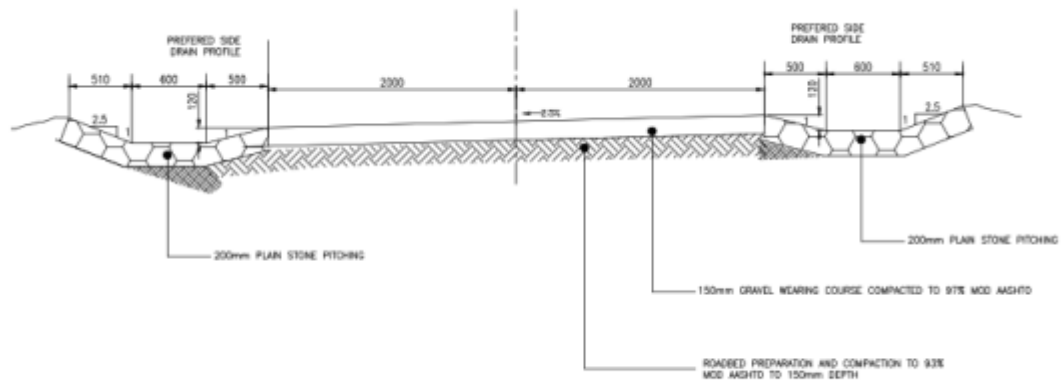

8. Technical specifications

8.1 Detailed description of the works

The detailed description of the work is provided by the drawings. The following is a summary description of the civil work to be undertaken under this contract.



8.2 Road cross-section

The road geometry will be a 4m road way on a 2.5% single crossfall with associated drainage channels. The road length is just under 2300m.

8.3 Layer works

a. Topsoil, Clearing and Grubbing

Remove topsoil from road prism to a depth of 200mm to windrows on edge of road reserve. Clearing and grubbing will only be undertaken on instruction from the engineer.

b. Subgrade and Roadbed Preparation

Rip and Compact 150mm of the existing in-situ subgrade material to 93% Mod AASHTO Density. Fill is to be constructed from gravel obtained from commercial sources and should be Natural gravel G9 as per the COLTO Specification or better.

c. Base/Gravel Wearing Course

Selected G7 as per the COLTO specification of better material from commercial sources will be used for the 150mm base/gravel wearing course layer that will be compacted to 97% Mod AASHTO Density.

d. Drainage

i) Stone Pitched Side Drain

A new 1600mm wide trapezoidal shaped side drain to be provided as shown on the typical cross-section drawings. The cross-sectional thickness of the side drains to be 200mm, this will be achieved by getting the material from commercial sources or crushed rock from previous construction activities on site. There is crushed rock available (free of charge) in close proximity to the road within the institution. The Contractor must ascertain the suitability of the material for the stone pitching of the side drains. On the lower side of the road, we will have mitre drains to discharge the stormwater.

ii) Cross Drains

There will be new 450mm diameter concrete pipes as well as 600mm diameter concrete pipes that will cross the road and have inlet and outlet structures to direct stormwater. This will have proper bedding and blanket over each pipe to give enough cover to the pipes.
